

## **Provisional List of Prospective Resolution Applicants in the Corporate Insolvency Resolution Process of ACCIL Corporation Private Limited**

**Date:** January 05, 2026

The Resolution Professional (“**RP**”), Mr. Chandra Prakash of ACCIL Corporation Private Limited (“**Corporate Debtor**”), vide Form G dated December 11, 2025, had published the Invitation for Expression of Interest (“**IEOI**”), inviting expression of interest (“**EOI**”) from Prospective Resolution Applicants (“**PRAs**”) for submission of their resolution plan with respect to the ongoing Corporate Insolvency Resolution Process (“**CIRP**”) of the Corporate Debtor.

Subsequently, the RP issued an Addendum dated December 24, 2025 to the IEOI.

The last date for submission of EOI, as specified in the IEOI, was December 26, 2025.

The RP has received 12 EOIs, for submission of resolution plans with respect to the ongoing CIRP of the Corporate Debtor. In accordance with sub-regulation (10) of Regulation 36A of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, (“**CIRP Regulations**”) please find below the provisional list of PRAs participating in the CIRP of the Corporate Debtor:

In case the RP/ Committee of Creditors (“CoC”) subsequently becomes aware of or is made aware of any disqualification/ineligibility of any PRA (including but not limited to Section 29A of the Insolvency and Bankruptcy Code, 2016), then the RP/CoC shall have the right to disqualify such PRA from the CIRP at any stage.
3. The RP may seek any clarification or additional information or document from the PRA under Regulation 36A of the CIRP Regulations.
4. For avoidance of doubt, it is clarified that the above information is strictly private and confidential and for the restricted purpose of issuing the provisional list of eligible PRAs as required under the CIRP Regulations.
